Subject: Ratify Procurement Plan of TEQIP - III for 18 Months.

Resolution: - The members discussed in details the plan submitted by the university. SPIU had modified the draft, which was also circulated in the committee. This was largely agreed however, AKU objected on rate and quantity of certain items. Further, regarding virtual classroom, Director (S&T) explained in detail about the state government plan regarding this with a studio in the Planetarium and classroom in all engineering colleges and suggested that to avoid duplicity, AKU can plan for a studio only. It was resolved that the rates/quantity of particular items may be reviewed in consultation with the SPIU. Accordingly, the university may re-submit the final procurement plan for 18 months to SPIU/NPIU through PMSS Software for further action. The board directed the university that the items of Virtual Classroom may be reviewed and accordingly may be placed in next board meeting to include in procurement plan. SPA, Bihar suggested holding meeting of procurement committee before the board meeting, like the academic committee so that minor issues can be sorted out there.
